irst Assistant Prosecutor Doris Galuchie, one of Mercer County's leading prosecutors, retired last month after three decades of service to the office. Galuchie career with the Mercer County Prosecutor's office as an intern after her second year of law school, then began as a full-time prosecutor after graduation, serving under Prosecutors Paul T. Koenig, Jr., Maryann K. Bielamowicz, Daniel G. Giaquinto, Joseph L. Bocchini, Jr., and Angelo J. Onofri. Galuchie stated that her "passion always lied in prosecution, and that it was an added honor and privilege to prosecute in the county where [she] has lived for most of [her] life." She prosecuted many high-profile cases and was well-regarded by the judiciary and her adversaries. Galuchie upheld a real sense of service, a belief in the rule of law, and an unwavering practice of prosecuting with fairness and humility.

Prosecutor Onofri reflected that "she was a brilliant trial attorney, a friend and confidant, and her retirement is a tremendous loss to the office. This office and Mercer County owe a debt of gratitude for all that she has done for the citizens of this great county. Attorneys on both sides of the bar respect Doris and regard her as a mentor, friend, and confidant." Nick C. Travisano, Esquire, noted that Galuchie was "knowledgeable, always prepared, and treated everyone around her with respect; victims, law enforcement, and defense attorneys alike. She will be missed by her colleagues in the prosecutor's office as well as the defense bar." Defense attorney Robin Lord expressed similar accolades Galuchie, stating that she was "one of the best prosecutors [she] came across in the courtroom. [Galuchie] was very shrewd, intelligent, and the MCPO will not be the same without her."

In addition to practicing attorneys, Judge Maria Marinari Sypek reflected upon Galuchie's court appearances. "In my years on the Criminal Bench, I was always confident when Prosecutor Galuchie was on the case, that the matter would be handled professionally due to her intelligence, practical approach, and preparedness. Ms. Galuchie used her talents, including her sense of humor, to assure a just

and fair outcome for every case. She is a wonderful role model for both men and women on how to perform as a prosecutor with strength and a good heart."

The Bar Association thanks Doris for her service to Mercer County and wishes her all the best in her future endeavors.

Mercer County Clerk's Update

Return Postage to be Covered on Fire, Primary, General Ballots

Postage will now be paid for on all vote-by-mail ballots for all future fire district, primary, and general elections, per a request by Mercer County Clerk Paula Sollami Covello. Previously, only mail-in ballots for general elections were paid for by the county and voters had to bear the cost for postage in other elections.

Sollami Covello was granted approval for the paid postage by the Mercer County Freeholder Board in March to pay for these as part of her office's County budget. "The Freeholders have been strong supporters in removing obstacles to voting," the County Clerk said. "This is a step in the right direction for the voting residents of Mercer County."

Vote-by-mail ballots for the general election are marked in the upper right corner with a note specifying that postage is not necessary if mailed in the United States. Going forward, all future fire district and primary ballots will be marked with the same notification.

The "Vote by Mail" law was enacted in New Jersey in 2009, changing the laws for what was once known as an "absentee" ballot, and allowing people to use a mail-in ballot for any reason.

The 2019 deadline to mail in a vote-by-mail ballot for the Primary Election is May 28. For the General, the deadline is October 29. Of course, voters may also walk into the County Clerk's office to submit their vote-by-mail ballots up until 3 PM on the day before each election.

AFFIDAVIT OF MERIT CONFERENCE - ECOURTS ENHANCEMENT By: Douglas H. Hurd, PJ.Cv. and Judith Irizarry, Civil Division Manager

he Affidavit of Merit Statute ("AMS"), N.J.S.A. 2A:53A-26 to -29, became The New Jersey effective in 1995. Supreme Court has considered the AMS 18 times, most recently in A.T. v. Cohen, 231 N.J. 337 (2017), where Justice LaVecchia mandated the implementation of new rules which require judiciary administrators to (1) notify parties litigating professional malpractice claims of their statutory obligations to file affidavits of merit and (2) schedule hearings to determine whether those affidavits are satisfactory. Court Rule 4:5B-4, "Professional Malpractice Case Management" (effective September 1, 2018), enacted in response to A.T. v. Cohen, creates a procedure in all malpractice cases in order to avoid protracted Affidavit of Merit ("AOM") litigation.

Also in response to the Supreme Court's decision, the New Jersey Judiciary electronic filing system, eCourts, was enhanced to provide notice to plaintiffs of the statutory requirement to file an AOM within 60 days (or 120 days with leave of the court) of the filing of the answer to a professional malpractice case. The notice includes the date by which the AOM is due and a statement indicating that: "the filing of the Affidavit of Merit is necessary to avoid dismissal of the complaint with prejudice." The notification occurs automatically upon filing of the answer to the complaint or counterclaim. If the AOM is not filed within 50 days of the answer, a second notice is automatically generated by eCourts. The system will not generate the notice in instances where an AOM or an Order to Waive the AOM is filed.

In past years, court staff relied on system generated reports to identify cases with answers filed where a Ferreira conference or case management conference was required. An additional feature added to the eCourts application consists of an automated message to court staff for professional malpractice claims. Upon review of the filed Answer in these cases, staff is alerted to schedule the Ferreira conference. When the Ferreira conference is scheduled, a notice to all parties is generated

containing the details of judge, date and time of the conference. These conferences are scheduled to take place within 90 days of the filing of the answer and are designed to address discovery issues as well as the adequacy of the AOM and the qualifications of the affiant.

While the application was enhanced to provide members of the public with access to case information and documents filed through eCourts, self-represented litigants are not able to file documents or receive notices through the electronic system. Due to this limitation, attorneys and the Court must continue the practice of serving all correspondence, papers and notices by traditional methods of service to pro se litigants. In Mercer, approximately 3% of professional malpractice cases have pro se plaintiffs.

In order to assist the filer, the application does provide a notice, in each instance when a document is submitted, of parties that will not receive an electronic notice of the filing. This allows the filer to easily identify which parties need to be served in paper to comply with service requirements.

In the past three years, an average of 81 professional malpractice cases per year were filed in the Mercer Civil Division. As of the end of January a total of 41 cases have been filed in the 2019 court year which will end on June 30, 2019. Mercer Civil has an active caseload of 142 professional malpractice cases at this time. An average of 92 professional malpractice cases are resolved each year.

Streamlining Jury Management Through Technology

he Mercer vicinage will soon be taking steps to improve the juror experience by exploring technological advances in the area of jury management. Some of these improvements have already been made in other New Jersey counties, and may prove to be a significant step toward improving the juror experience in Mercer County.

One such area involves grand jury voting. Traditionally, grand jurors vote on indictments by deliberating, followed with a vote by a raise of hands. The result is documented, and reports are manually created and printed by the court clerk. This observable voting process has the potential to affect juror decision making and influence juror voting.

Mercer is investigating how electronic voting software could lessen the obviousness of juror votes by making the process more anonymous. Several other counties have already successfully implemented electronic voting in their grand jury courtrooms. Electronic voting software involves assigning each grand juror a handheld remote device, which is used to cast a vote for or

against indictment. Jurors vote in secret, and the votes are tallied electronically and displayed to the court clerk. Not only is electronic voting reported to make the process more efficient in terms of reports, it may reduce any anxiety jurors may feel when voting.

Another new change coming to Mercer in 2019 is the implementation of the new Jury Management System (JMS). Jury Management offices across the state will be implementing this new software this year, which will replace the legacy system. JMS will reduce Judiciary costs by utilizing increased electronic communications with jurors, including text and email communications, in lieu of traditional mail. In addition, jury summonses will be sent in postcard format, instructing jurors to respond online. Those that do not respond online within a specified time period will be mailed a questionnaire. The Mercer vicinage anticipates using this new system in May 2019.




