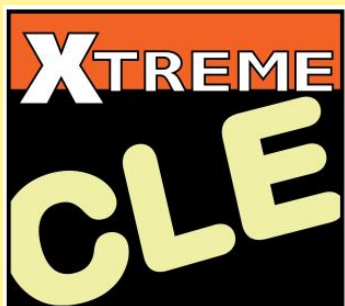

Mercer County Clerk's Update

County Clerk Announces Notary Education Class for Fall

Mercer County Clerk Paula Sollami Covello has announced that she will once again be offering a notary education class, along with two local attorneys, at the Mercer County Connection office in Hamilton. The class is open to all notaries public and those interested in becoming a notary public. The two-hour, non-credit course will be presented by County Clerk Paula Sollami Covello, Maeve E. Cannon, Esq. and Ryan P. Kennedy, Esq. of Stevens and Lee, PC, on Wednesday, September 18, 2019 at 10:00 AM at the Mercer County Connection Satellite Office on Route 33 in Hamilton Township.

Those enrolled in the class will learn to perform their duties with confidence and diligence, and learn about liability issues. Current notaries public will learn a new skillset and new technologies to assist them in their daily functions. Prospective notaries public will learn how to obtain or renew a notary commission and get an understanding of the steps needed to become a notary public.

"Notaries are incredibly important to the business community," said Mercer County Clerk Paula Sollami Covello. "This course will educate both notaries public and those interested in becoming one on how to perform their responsibilities properly and faithfully."

In-depth topics to be covered at the seminar include:

- Steps for proper notarization
- How to complete a Notary Journal
- How to examine identification
- Simple explanations of New Jersey Notary Laws
- Avoiding serious problems by learning how to perform notarizations without errors.

While there is no law requiring prospective notaries public to enroll in an education class at this time, the duties which a notary must fulfill can have legal ramifications if not performed with care. For this reason, the County Clerk and these attorneys offer this opportunity. The Mercer County Clerk's Office swears in new notaries at its main location at 209 South Broad St in Trenton, and also monthly at the County Connection Office.

To register for the class, you may contact the Mercer County Clerk's Office at 609-989-6820. You may also visit <http://www.mercercounty.org/government/county-clerk-/office-services/notary-public> for more information. The course is limited to 40 individuals, so those who wish to take part should register as soon as possible. You may register for a fee of \$15. This fee includes refreshments and class materials.

A notary public is a state-appointed public officer who serves as an impartial witness in the signing of documents and attests signatures. Under the authority of the State Treasurer, notaries serve for a five-year period and many renew the notary commission in five-year increments. Notary public candidates must reside or be employed in Mercer County and be at least 18 years of age.

Streamlining Jury Management Through Technology

The Mercer vicinage will soon be taking steps to improve the juror experience by exploring technological advances in the area of jury management. Some of these improvements have already been made in other New Jersey counties, and may prove to be a significant step toward improving the juror experience in Mercer County.

One such area involves grand jury voting. Traditionally, grand jurors vote on indictments by deliberating, followed with a vote by a raise of hands. The result is documented, and reports are manually created and printed by the court clerk. This observable voting process has the potential to affect juror decision making and influence juror voting.

Mercer is investigating how electronic voting software could lessen the obviousness of juror votes by making the process more anonymous. Several other counties have already successfully implemented electronic voting in their grand jury courtrooms. Electronic voting software involves assigning each grand juror a hand-held remote device, which is used to cast a vote for or against indictment. Jurors vote in secret, and the votes are tallied electronically and

displayed to the court clerk. Not only is electronic voting reported to make the process more efficient in terms of reports, it may reduce any anxiety jurors may feel when voting.

Another new change coming to Mercer in 2019 is the implementation of the new Jury Management System (JMS). Jury Management offices across the state will be implementing this new software this year, which will replace the legacy system. JMS will reduce Judiciary costs by utilizing increased electronic communications with jurors, including text and email communications, in lieu of traditional mail. In addition, jury summonses will be sent in postcard format, instructing jurors to respond online. Those that do not respond online within a specified time period will be mailed a questionnaire. The Mercer vicinage anticipates using this new system in May 2019.

Family Section Update

A Family Part Bench Bar meeting was held on May 23, 2019. At the meeting, Judge Fitzpatrick, Judge Lougy and Judge McLaughlin provided some guidance on the Mercer County Family Part's new adjournment policy, as well as some practical tips important for practice within the county.

The judges indicated that adjournment of trial dates will now only occur in emergent circumstances. For other types of appearances, if an adjournment is granted at all, it will generally only be for a maximum of fourteen (14) days. Judge Fitzpatrick made clear that attorneys should not assume that being recently retained will guarantee an adjournment and that you may be forced to appear before the court for the particular hearing to deal with any pressing issues before any adjournment will be granted (if an adjournment is otherwise warranted).

All settled matters with support provisions must be accompanied by a completed USSO, even if the support obligations are not to be administered through Probation and are direct pay obligations between the litigants. The Bar has taken some complaints from attorneys that errors are being made where Probation accounts are being created and enforcement occurring despite provisions in Marital Settlement Agreements avoiding Probation and providing for direct pay. If you have this issue in one of your matters, or you find any other support collection errors, you should immediately contact the FM Team Leader Lida Perez at (609) 571-4200 x74423.

Judge Fitzpatrick indicated that, while the Court is still accepting uncontested divorces "on the papers," all name change applications must include the appropriate voir dire in the parties' certification(s). The name change application cannot be granted without an appearance or the proper voir dire in an executed certification.

Lastly, the Court will not honor Consent Orders that call for the parties to return to parenting time mediation post-judgment. If the parties agree to return to Court-annexed parenting time mediation, one party must still file an application with the Court with the request, and the other party can simply notify the Court that such application is uncontested. Court staff will then schedule the parties for parenting time mediation. If the request is time sensitive and the parties do not wish to wait for the normal motion cycle, attorneys should contact chambers and alert the law clerk as to their requests and any time sensitive scheduling concerns.

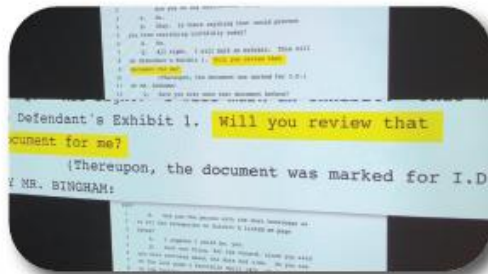
